## Community Benefit Fund Guidance Notes

Since 2008, Rosemount Development Trust have donated £1,024,646.00 to community causes in Royston.

Every year we make awards to local organisations via our Community Benefit Fund for projects or activities which align with our objectives, namely;

- To benefit residents of Royston
- To benefit areas neighbouring Royston
- To prevent and/or relieve poverty
- To relieve unemployment
- To advance citizenship and community development
- To relieve those in need by reason of age (young or old)
- To relieve those experiencing ill-health
- To assist those affected by disability
- To assist those facing financial hardship

The Community Benefit Fund is open to charitable or voluntary organisations based in Royston or Germiston and will award organisations a maximum of £1,000 in any one financial year. Should organisations be unsuccessful with an application, they are welcome to reapply within the same year.

Applications from individuals or for funding exceeding £1,000 are generally not encouraged, however the Board will consider these in exceptional circumstances.

If you wish to submit an application that falls within these categories please get in touch first.

Rosemount Development Trust will **not** pay grants to an individual, groups must have a registered bank account. We recognise that in some cases, smaller groups may not have a bank account. If this is the case, we are willing to work with applicants to find a solution. Please get in touch prior to submitting an application to discuss if this is the case.
